

Instructions for filling out the One Day Show **and Value Show** Recognition Application Form

AHA One Day Shows and AHA Value Shows may run as a Concurrent Show. Your recognition fee will vary depending on the Judges you hire.

9-90 fees are due for all shows regardless of the number of horses or Judges used.

Reminder – both the Show Manger and Show Secretary must be AHA members from the time of application thru the end of the show. The Secretary will be the party listed on the AHA web site as the contact person.

If a club, organization or business is putting on the show(s), please list that entity as the sponsor not an individual member of the entity.

For a One Day Show –May be a concurrent show. If the show has over 100 horses an additional \$50.00 must also be submitted with show results. Must have One Day or ODS in the title of the show.

For a Value Show – May be 1 to 3 consecutive days. If the show has over 100 horses an additional \$200.00 must also be submitted with show results. Must have Value or AVS in the title of the show.

For a show running more than 1 day OR with a “R” or Specialty Judge, you must apply for a Value show.

AHA APPROVAL FEES

For an AHA One Day Show with a single Judge. If it will be a concurrent One Day Show, please check the box

- You **must** use an AHA “r” Judge. For a concurrent One Day Show, both judges must be “r”
 - Application fee will be 50.00 (per shows) for a single judge – \$100 per day for a concurrent show.
Plus \$4.00 per horse post recognition fee / per show
(9-90 Fee is \$4.00 per horse single Judge - \$7.00 for a concurrent show)

For an AHA Value Show (Single Judge)

- For a one day show using a “r” Judge, you must apply for a One Day Show.
- For 2 – 3 days using a “r” Judge will be \$50 per day (2 days = \$100, 3 days = \$150)
- For 1 – 3 days using a “R” Judge will be 150. Per day (1 day = \$150, 2 days = \$300, 3 days = \$450)
 - Plus \$4.00 per horse post recognition fee / per show and 9-90 Fee is \$4.00 per horse

For a Concurrent AHA Value Show (Double Judge)

- For 2 – 3 day using a “r” Judge will be (2 days = \$ 200, 3 days = \$ 300)
- For 1 – 3 Day using one “r” and one “R” Judge will be (1 day = \$200, 2 days = \$350, 3 days = \$500)
- For 1 – 3 Day using 2 “R” Judge will be (1 day \$300 =, 2 days = \$450, 3 days =\$600)
 - Plus \$4.00 per horse post recognition fee / per show (\$8.00 total) and 9-90 Fee \$7.00 per horse
