



## 2021 Distance Horse National Championships AHA, ApHC, PFHA, PShR, AMHA, ATAA & ASHBA AERC/AHA/SERA Big South Fork Open Rides Championship & Open Entry Explanations

- ✓ There are early discounts and late fees this year! If you have your entry received to the AHA office by August 19<sup>th</sup> please subtract \$25 per competitor for your early entry, for example if one rider is entering 3 horses you would subtract \$25 total for all 3 horses. If you have your entry received in the office from August 20<sup>th</sup> to September 1<sup>st</sup> there is no discount. After September 1<sup>st</sup> please hand carry your entry to the ride. **If you enter at the ride there will be a \$25 late fee assessed per competitor.**
- ✓ Please make sure full registered name and registration number is filled out for each horse entered. Please also make sure all membership numbers are filled out correctly and double check registration papers to make sure the horse does not need to be officially transferred with the appropriate organization.
- ✓ If the horse is not registered and is only going enter the Open Big South Fork Rides you do need to list the horse's name and all other information as best you can. If you are entering the Open Big South Fork Ride only you do not need to hold any membership cards other than an AERC membership. If you do not have an AERC membership you may purchase a 1 day pass at the event for \$15. There are no qualification requirements for any of the Open Big South Fork Rides, including the LD Challenge.
- ✓ All Championship Entrants are automatically entered into the corresponding Open Ride; all Championship fees listed include the Open Rides fee. For example if you enter the AHA 100 Mile Championship you are paying a total of \$310 for your entry fee because the Open \$160 portion is built into that Championships fee.
- ✓ If you have a Half-Arabian that is also registered with any other breed organization and wish to enter both breed Championships for that division you only need to pay the Open portion of that fee once. For Example if you choose to enter the AHA 50 Mile National Championship and the 50 Mile Appaloosa National Championship then you would check both boxes but only pay a total of \$340; \$150 (AHA), \$65 (ApHC) & \$125 for the Open.
- ✓ Completion awards for the AHA National Championship Rides are the option of either a buckle or cuff (bracelet). If you choose the cuff option please check the box at the bottom of the entry form and pay the additional \$10 surcharge for that award.
- ✓ If you are entering the LD Challenge you must designate before the beginning of the first LD ride. You must also pay the \$25 LD Challenge Fee in order to be officially entered in the event; this \$25 fee is built into the LD Challenge designation on the entry form.

**AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA TERMS AND CONDITIONS FOR  
ENTRY RELEASE WAIVER AND INDEMNIFICATION AGREEMENT**

Every person or entity executing this entry form agrees and represents that: (1) the person and entity executing this entry form and the horse(s) to be exhibited by the entrant are subject to and bound by Rules of the Arabian Horse Association ("AHA"), the Appaloosa Horse Club ("ApHC"), the Paso Fino Horse Association ("PFHA"), the Performance Shagya-Arabian Registry ("PShR"), the American Morgan Horse Association ("AMHA"), the Akhal-Teke Association of America ("ATAA"), the American Saddlebred Horse & Breeders Association ("ASHBA") and the rules of the entity or entities that are responsible for organizing and conducting the event (the "Ride"); (2) that every horse, rider, driver and handler is eligible as entered; (3) that the entrant and any of his representatives agree to accept as final the decision of any applicable hearing committee authorized by AHA, ApHC, PFHA, PShR, AMHA, ATAA on any question arising under AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA and the Ride, as applicable; (4) that permission to enter a horse and the rental of any storage, stall, or tack space, if granted, shall not create a bailment between AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Regions (Region 12) or the Knoxville Arabian Horse Club, the facilities leased by "the Ride" (Big South Fork River & Recreation Area) and state wherein held (Tennessee), and the entrant or others and, at all times, horse and any other property belonging to or accompanying the entrant shall be under the care, custody, control and supervision of the entrant; (5) the entrant agrees to fully indemnify and hold harmless AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA the Regions (Region 12), the Ride, the facilities leased by "the Ride" (Big South Fork River & Recreation Area) and the state wherein held (Tennessee), and their agents, employees, contractors, officials, officers, directors, successors and assigns from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries, liabilities and obligations, including, but not limited to, any and all attorneys' fees, of whatsoever kind and nature which may be incurred by or asserted against any of them as a result of any act, failure to act, or neglect by the entrant, his agents, employees, riders, handlers, trainers, coaches, drivers, contractors or invitees, or by any animal owned by, accompanying or exhibited by the entrant; (6) the parties executing this entry form, for themselves, their heirs, executors, administrators, successors and assigns release and forever discharge AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Regions (Region 12), the facilities leased by "the Ride" (Big South Fork River & Recreation Area) and the state wherein held (Tennessee), and the Knoxville Arabian Horse Club, their officials, officers, directors, agents, employees, contractors, successors and assigns from any and all rights and claims for any damage, loss or injury to themselves, other persons, horses or other property belonging to them to the fullest extent permitted by law arising out of or relating in any way to the Ride and participation in the Ride including, but not limited to, damages resulting from or due in whole or in part to any acts, failure to act, negligence or neglect of other entrants, AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA, the Ride, the Region (Region 12), the facilities leased by "the Ride" (Big South Fork River & Recreation Area) and state wherein held (Tennessee), and the Knoxville Arabian Horse Club, or their agents, employees, officials, officers, directors, contractors or invitees, as well as for theft vandalism, fire, other casualty damage, or damage arising out of any defects in the premises; (7) the entrant acknowledges that AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event and grants AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASR the right to make use of any photographs, films or videotapes taken of the below entered horse(s) and riders/drivers/handlers while on the grounds or in transit between the stabling facilities and the event site, in any way they see fit in the promotion of the Ride, AHA, ApHC, PFHA, PShR, AMHA, ATAA and ASHBA. No such advertising or promotional rights shall include the right to use a participant's name or likeness in a manner which implies endorsement of any company, product or product category, or service; (8) if AHA, ApHC, PFHA, PShR, AMHA, ATAA, ASHBA in its sole discretion, deems that circumstances have arisen which require cancellation of the Ride in its entirety, or cancellation of any particular event during the Ride, then all applicable fees shall be refunded in full, but AHA, ApHC, PFHA, PShR, AMHA, ATAA and ASHBA shall not be liable or otherwise responsible to the parties executing this form or any of their representatives for any costs, damages or expenses resulting directly or indirectly from such cancellation.

**I AGREE** as a Distance Ride Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Distance Ride (and most other outdoor locations) and can cause infection in humans, as well as in animals.
