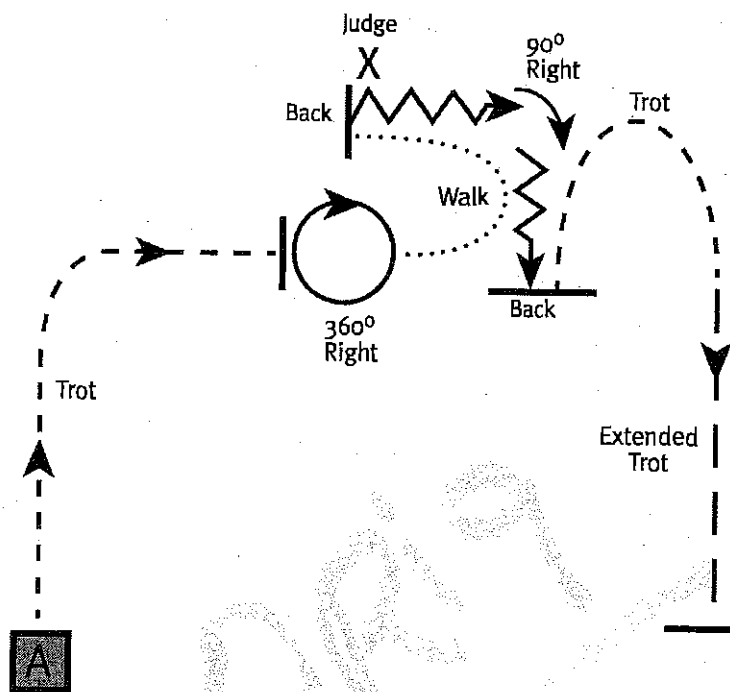

## LEVEL 3 • PATTERN PP

Exhibitors are to complete the pattern on the side of the marker as indicated in the drawing



Be ready at marker A.

Trot as shown.

Stop, execute a 360-degree turn to the right.

Walk, stop when horse's hip is even with Judge.

Set up.

Inspection.

When dismissed, back, execute a 90-degree turn to the right, back.

Trot.

Extended trot to gate, halt.

Return to line up or exit arena as directed by ringmaster.

Be ready at marker A.

Walk to and around marker B.

Trot curve directly to marker C.

Stop, execute 450-degree turn.

Trot curve directly to marker D.

Stop. Back until even with Judge.

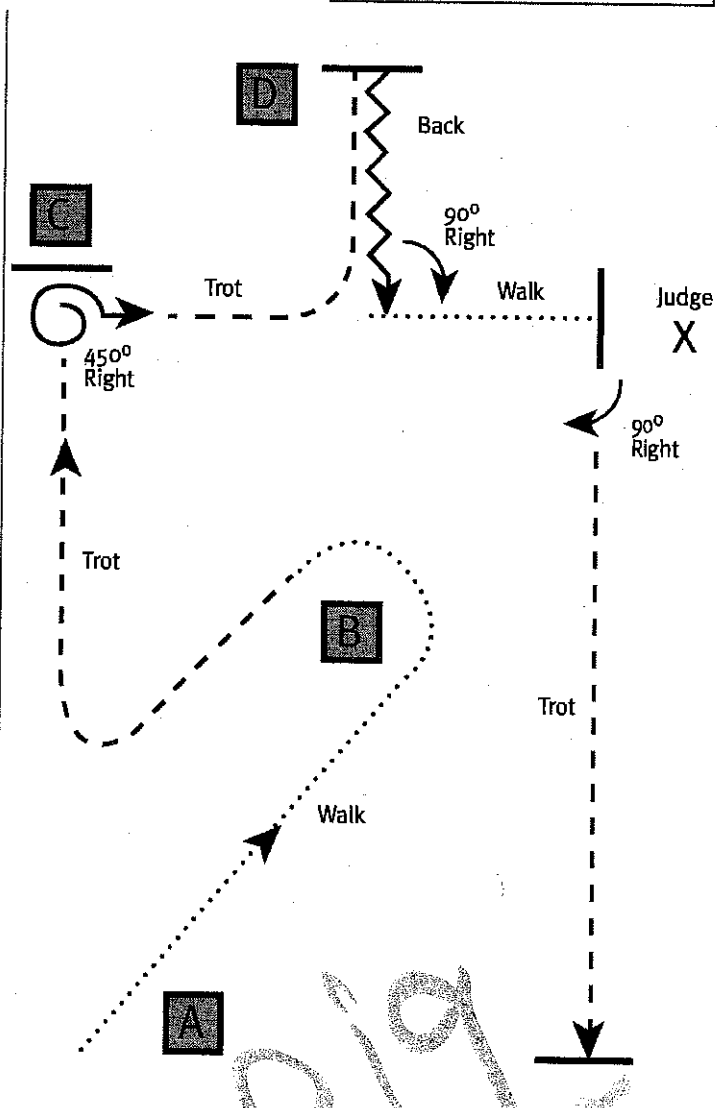
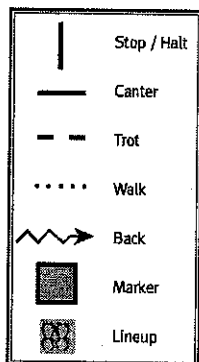
Execute 90-degree turn. Walk to Judge.

Stop and set up for inspection.

When dismissed, execute a 90-degree turn.

Trot away as drawn. Stop when even with marker A.

Return to the lineup at the trot or exit as directed by the ringmaster.
